

# Privacy Policy

## Indivisible Huron Valley

Indivisible Huron Valley (IHV) values the privacy of our members, donors and visitors. IHV collects information to only help us better serve our members. It is our policy to collect and store only personal information that is knowingly provided to us. We do not share personal information

This Privacy Policy explains our practices regarding the collection of information from our official IHV website, official IHV social media sites, and other IHV membership enrollment that can personally identify you and the choices you make about the way your information is collected and used.

### Personal Information Collected

IHV collects and stores contact information from individuals as it is knowingly provided to us, including email addresses. IHV does not share personal information of its members, unless compelled by law. IHV does not distribute personal information or email addresses to third parties. We use this information to contact individuals via email, phone, text, and mail with additional resources that might be of interest.

Communications may include upcoming events and trainings, new publications, or other resources. You may choose at any time not to provide personally identifiable information, although this may restrict our ability to provide requested services or information.

The following are examples of personally identifiable information that you may volunteer to provide and examples of how we use such information.

Purpose	Data (key elements)	Basis
Asking a question about our organization and its work	Name, email, message	Legitimate interests - it is necessary for us to read and store your message so that we can respond in the way that you would expect.
Signing up as a member	Name, email, phone, address, volunteer interests	Legitimate interests – this information is necessary to provide information related to the organization and to the volunteer interests you selected Consent – by signing up as a member you have given your active consent to receive emails regarding our work, actions and related information.
Making a donation	Name, email, address, payment information	Legitimate interests - this information is necessary for us to fulfill your intention of donating money and your expectation of receiving a confirmation message.
Website functionality	Website activity collected through cookies	Legitimate interests - it is necessary for us to store a small amount of information, usually through cookies*, to deliver functionality that you would expect, such as remembering the contents of your order before you have fully completed the process.

\* You can select to disable cookies by changing your browser settings. If you choose to disable cookies in your browser, you will not be able to access portions of our website content.)

## Embedded Content from Other Websites

Articles on the Official IHV website, email or other social media sites may include embedded content (e.g. videos, images, articles, etc.). Embedded content from other websites behaves in the exact same way as if the visitor has visited the other website.

These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that embedded content, including tracing your interaction with the embedded content if you have an account and are logged in to that website.

## How Long We Retain Your Data

For users that register on our website, at a meeting, or by contacting IHV directly, we store the personal information the users provide in their user profiles indefinitely. All users can request to edit or delete their personal information at any time support@indivisiblehv.com.

## Choice to Opt Out

IHV provides all members the opportunity to opt out of having your personal information used for certain purposes. All users can request to edit or delete their personal information at any time (support@indivisiblehv.com). You may opt out of receiving communications by selecting Unsubscribe at the bottom of the email. This does not include any data we are obliged to keep for administrative, legal, or security purposes. Unsubscribing to IHV email does not remove the user from IHV membership.
